FAQs about the Swine (H1N1) Flu

The Centers for Disease Control and Prevention announced last week that the H1N1 virus continues to circulate in the U.S. and that the known confirmed and probable cases represent only a portion of the number of people that are infected or ill from the virus. For every one reported case, it is estimated that there may be 20 other individuals sickened by the virus.

The production of a flu vaccine is nearly complete and the US government has set aside \$1 billion in existing preparedness funds to manufacture two important parts of a vaccine for the Strategic National Stockpile, to produce small amounts of potential vaccine for research, and to perform clinical research over the summer.

Kentucky has reported only “sporadic” activity with this outbreak (27 cases as of May 16th), however, some basic information and precautions from the CDC are provided herein:

What are the signs and symptoms of this virus in people?

The symptoms of this new H1N1 flu virus in people are similar to the symptoms of seasonal flu and include fever, cough, sore throat, runny or stuffy nose, body aches, headache, chills and fatigue. A significant number of people who have been infected with this virus also have reported diarrhea and vomiting.

How does this new H1N1 virus spread?

Spread of this H1N1 virus is thought to be happening in the same way that seasonal flu spreads.

Flu viruses are spread mainly from person to person through coughing or sneezing by people with influenza. Sometimes people may become infected by touching something with flu viruses on it and then touching their mouth or nose.

How long can an infected person spread this virus to others?

At the current time, CDC believes that this virus has the same properties in terms of spread as seasonal flu viruses. With seasonal flu, studies have shown that people may be contagious from one day before they develop symptoms to up to 7 days after they get sick. Children, especially younger children, might potentially be contagious for longer periods.

What can I do to protect myself from getting sick?

There is no vaccine available right now to protect against this new H1N1 virus. There are everyday actions that can help prevent the spread of germs that cause respiratory illnesses like influenza.

Take these everyday steps to protect your health:

- Cover your nose and mouth with a tissue when you cough or sneeze. Throw the tissue in the trash after you use it.
- Wash your hands often with soap and water, especially after you cough or sneeze. Alcohol-based hand cleaners are also effective.

MAY COUNCIL MEETING

The regular meeting of the City Council of Pewee Valley, Kentucky was held on May 4, 2009. In attendance were Mayor Bob Rogers, Council Members Dick Filippini, Bethany Major, Amy Johnson, Dana Barrette, Will Chambers, and Carol Akers. Also in attendance were John Singler, City Attorney, and Laura Eichenberger, City Clerk.

FINANCIAL REPORT

No report given.

OPEN COMMENTS

Resident Marsha Chadwick, addressed the Council regarding a portion of severely damaged sidewalk located west of Central Avenue and south of Edgewood Way. The damage occurred as a result of the January 2009 Ice Storm. The location of the damage is such that pedestrians can maneuver around it; but children on bikes, in strollers, etc., are at risk of injury. Mayor Rogers responded that, although this is a state road, the City is responsible for the repairs.

FIRE DEPARTMENT REPORT

No report given.

POLICE REPORT

Chief Mike Losik reported that in response to the swine flu outbreak, the U.S. Government has declared a public health emergency. As of this morning, there were four reported cases in Kentucky. Chief Losik stated that provided we learn what it is we are dealing with and the proper steps we can take to prevent the further spread, the quicker we can eliminate this health emergency. He has obtained a question and answer sheet that is available to anyone who is interested. This sheet will be forwarded to Paula Kennedy for publication in The Call of the Pewee.

ANNOUNCEMENTS

Tree Board Meeting - Mayor Rogers announced that the Tree Board May meeting is cancelled due to the Memorial Day holiday. The next regular scheduled Tree Board meeting is June 22, 2009, 7:00 p.m., at Town Hall.

FEMA Reimbursement - Mayor Rogers reported that the City has submitted the request for FEMA reimbursement for the January 2009 Ice Storm damages in the amount of \$25,038.94. If approved, a total of \$21,783.88 will be reimbursed by FEMA (Federal reimburses 75% of the total and the State 12%. The City's share is 13%).

Quiet Zone - Houston Lane Crossing - Mel Milburn, City Engineer, and Diane Zimmerman, a Traffic Engineer expert, met with Chief Losik and Mayor Rogers after completing traffic studies at the Houston Lane railroad crossing. In order to meet the requirements for a Quiet Zone Crossing, Houston Lane must be changed from two-way to one-way traffic. The recommendation from the Engineers is that Houston Lane be made one-way going out onto Highway 146.

The Council discussed issues regarding making the Houston Lane crossing a right turn only. The Traffic Report showed the number of left turns off Houston onto Highway 146 were minimal. It was noted from the April minutes that the Council asked only for recommendations regarding the direction of the one-way restriction on Houston. The Council asked Mayor Rogers to ask Mel Milburn for a recommendation regarding left and/or right turn restrictions. The issue must be

decided before plans are drawn and submitted to the Federal Railroad Commission.

COUNCIL MEMBER REPORTS

Dick Filippini (Tree Board): No report given.

Bethany Major (Town Hall/Festivities): Bethany Major reminded everyone of the upcoming Summer Picnic and reported that she is still working on banners.

The last price estimate for demolishing the garage on the Morris property was approximately \$2,225. We are continuing to receive complaints that the garage is an eyesore. (Dick Filippini and Dana Barrette have met with John Malueg on ideas for keeping the Morris property as green space. This will help with meeting the storm water mandate credits for public education and participation. The more pro-active the City is with water gardens, green space, etc., the better.)

Carol Akers (Public Safety): Carol Akers reported she has spoken with State Representative Ernie Harris, about signs. She is now awaiting a call from someone with the Department of Transportation.

LG&E is scheduled to meet Carol tomorrow to identify the lights to be taken out on Mt. Mercy. They will also identify the light on Rollington Road to be removed (there have been requests to remove this light since last fall).

Dana Barrette (Storm Water/Insurance/Finance): Dana Barrette reported on the follow-up meeting with John Malueg. The City needs money budgeted next fiscal year for activities across six or seven areas of the Minimum Control Measures to meet the Storm Water requirements.

Councilman Barrette also reported that the City exceeded the amount budgeted (\$10,000) in insurance tax receipts.

Amy Johnson (Sidewalks/Communications): Amy Johnson reported that the sidewalk budget is expended for the fiscal year. The City is still waiting on funds from Frankfort. Mayor Rogers responded that the City Engineer must attend a Federal grant seminar (scheduled for Wednesday) as part of the grant requirements. We are hoping they will pay 100% for extending the sidewalk all the way to Foley.

Amy also reported that the Oral History project is coming along. The NEH grant deadline has been extended to July. Amy and Bethany are working on the grant together. Amy is also looking into making the City's website updateable directly from the clerk's office. One bid on a new website design has been received.

Will Chambers (Waste Management/Mowing): No report given.

Bob Rogers (Police/Roads): Mayor Rogers reported that he spoke with State Representative Ernie Harris last night regarding the Shovel Ready Projects funding the City requested. It looks as though the funding will not be awarded to the City. The road work on Elm and Cherry will have to be funded from the Roads Budget.

OLD BUSINESS

For Second Reading: Ordinance #2, Series 2009, An Ordinance Establishing a Storm and Surface Water Drainage System - John Singler recommends this ordinance be tabled until the June meeting. The ordinance sets the rate and establishes the utility with the Storm Water User Fee Policy. Stantec recommends that we not adopt this one until the regulating ordinance is adopted. The rate (middle level of services, approximately \$3 per month) will be set at the June meeting.

Dana Barrette presented the suggestion from John Maleug of Stantec, to change the terms "Storm Water" and "Surface Water Drainage" to "Water Quality System" and "Water Quality Management." The Council agreed to use the terms as suggested.

A motion to table Ordinance #2, Series 2009, An Ordinance Establishing a Water Quality System until the June meeting was made and seconded. All Council members voted in favor.

reported that this ordinance combines all the facets required to regulate construction activities into a combined format suggested by Stan-tec. The ordinance has gone through the Council for the first reading, with comments from Mel Milburn and changes made by John Singler. This is the second reading by summary presented by John Singler, City Attorney.

A motion to adopt Ordinance #1, Series 2009, Water Quality System Management, was made by Dana Barrette, seconded by Dick Filip-pini. A roll call vote was taken. The motion was voted all in favor and the Ordinance was adopted by the City Council.

NEW BUSINESS

Resolution and Inter-Local Agreement - Kevin Nuss, Director of Oldham County Emergency Management and Dispatch, presented a Resolution for restricting access to information received from LINK/NCIC (Law Enforcement Network of Kentucky/National Crime Information Center). The Resolution states that Oldham County officials have agreed to place responsibility for the management control of Oldham County Dispatch with the Oldham County Dispatch Operations Board (that includes the Pewee Valley Police Chief).

A motion to enter into the Inter-local Agree-ment with Oldham County for the purpose of establishing management control of Oldham County Dispatch and thereby information ob-

tained through LINK/NCIC, etc., was made and seconded. All members of the Council voted in favor.

Interlocal Cooperation Agreement, 2009 Mass Notification System - Kevin Nuss present-ed for approval, the Agreement between the City and the County to continue participation with the Oldham County Emergency Notification Sys-tem. Oldham County is working with One Call Now on a four-year contract that locks in current rates and provides the fourth year free. Pewee Valley's share of the total \$16,400 annual pre-mium is \$574.96 (effective July 31, 2009 through June 1, 2010). The City's portion of the premium would be due annually thereafter through June 2012 (when the fourth year premium is free). The purpose of the notification system is to provide off-hour emergency notification by telephone to County residents. There are only six emergency notification sirens within Oldham County. Resi-dents outside of a 1 to 1 ½ mile radius of those sirens cannot hear them. All County residential phone numbers are automatically included in the One Call Now system (unless a resident has noti-fied OC Emergency Management and Dispatch to opt out).

A motion to enter into the Inter-Local Agree-ment for the Oldham County 2009 Mass Emer-gency Notification System was made and second-ed. The Council unanimously voted in favor.

Ash Avenue Resolution and Grant As-sumption and Assignment - Beth Stuber, Old-ham County Engineer, reported to the Council

that a grant was obtained by Oldham County to address the drainage/flooding problems and aging infrastructure on the lower end of Ash Avenue (outside of Pewee Valley City proper and under the responsibility of Oldham County). The grant monies obtained through the assistance of David Osbourne, State Representative, were erroneously assigned to Pewee Valley instead of Oldham County through a clerical error. The City of Pewee Valley must adopt the Resolution, and Grant Assumption and Assignment Agreement to return the funds to Oldham County.

A motion was made and seconded. All members of the Council voted in favor.

For First Reading: Ordinance #5, An Ordinance Establishing the Budget for the City of Pewee Valley for the Fiscal Year Beginning July 1, 2009 and Ending June 30, 2010 - John Singler and Dana Barrette presented the budget ordinance for fiscal year 2009/2010. A motion to accept the first reading was made and seconded. All Council members voted in favor.

For First Reading: Ordinance #6, An Ordinance Establishing the Tax Rate for the City of Pewee Valley for the Fiscal Year Beginning July 1, 2009 and Ending June 30, 2010 - John Singler and Dana Barrette presented the ordinance for establishing the tax rate for fiscal year 2009/2010 (the proposed rate .1439 is the same as the previous fiscal year). John Singler suggests that the City hold the ordinance after the first reading until the tax rolls are certified

to avoid having to amend the ordinance later. A motion was made and seconded. The Council voted in favor.

Property Tax Assessments - Dick Filippini noted to the Council that some property owners were receiving their increase notification letter around the first of May (we were told initially that the notices were mailed well before then). The appeals dates are now through May 18th.

Call of the Pewee - Dick Filippini noted that Paula Kennedy is doing an outstanding job with the Call of the Pewee and that it was an excellent city newsletter. The Mayor and the Council agreed to publically acknowledge a job well done by Paula.

Mt. Mercy Street Closing, April 11, 2009 (PVFD 5K Run for Crusade for Children) - Dick Filippini received several phone calls from neighbors regarding the closing of Mt. Mercy for the PVFD 5K Run. The City was not notified prior to the event. Chief Mike Losik noted that the Council enacted a permit requirement for any type of run or walk event. Chief Losik will contact Chief Bob Hamilton of the Fire Department and request that the City be given 60 days advance notice of these events.

Mayor Rogers will also contact Chief Hamilton about a representative from the Fire Department attending the City Council meetings on a regular basis.

Upon approval of payment of outstanding bills, the Council voted unanimously to adjourn.

- Avoid touching your eyes, nose or mouth. Germs spread this way.
- Try to avoid close contact with sick people.
- Stay home if you are sick for 7 days after your symptoms begin or until you have been symptom-free for 24 hours, whichever is longer. This is to keep from infecting others and spreading the virus further.

Other important actions that you can take are:

- Follow public health advice regarding school closures, avoiding crowds and other social distancing measures.
- Be prepared in case you get sick and need to stay home for a week or so; a supply of over-the-counter medicines, alcohol-based hand rubs, tissues and other related items might be useful and help avoid the need to make trips out in public while you are sick and contagious.

What is the best way to keep from spreading the virus through coughing or sneezing?

If you are sick, limit your contact with other people as much as possible. If you are sick, stay home for 7 days after your symptoms begin or until you have been symptom-free for 24 hours, whichever is longer. Cover your mouth and nose with a tissue when coughing or sneezing. Put your used tissue in the waste basket. Then, clean your hands, and do so every time you cough or sneeze.

What should I do if I get sick?

If you live in areas where people have been identified with new H1N1 flu and become ill with influenza-like symptoms, including fever, body aches, runny or stuffy nose, sore throat, nausea, or vomiting or diarrhea, you should stay home and avoid contact with other people, except to seek medical care.

If you have a severe illness or you are at high risk for flu complications, contact your health care provider or seek medical care. Your health care provider will determine whether flu testing or treatment is needed.

If you become ill and experience any of the following warning signs, seek emergency medical care.

In children, emergency warning signs that need urgent medical attention include:

- Fast breathing or trouble breathing
- Bluish or gray skin color
- Not drinking enough fluids
- Severe or persistent vomiting
- Not waking up or not interacting
- Being so irritable that the child does not want to be held
- Flu-like symptoms improve but then return with fever and worse cough

In adults, emergency warning signs that need urgent medical attention include:

- Difficulty breathing or shortness of breath
- Pain or pressure in the chest or abdomen
- Sudden dizziness
- Confusion
- Severe or persistent vomiting
- Flu-like symptoms improve but then return with fever and worse cough

How long can influenza virus remain viable on objects (such as books and doorknobs)?

Studies have shown that influenza virus can survive on environmental surfaces and can infect a person for up to 2-8 hours after being deposited on the surface.

What kills influenza virus?

Influenza virus is destroyed by heat (167-212°F). In addition, several chemical germicides, including chlorine, hydrogen peroxide, detergents (soap), iodophors (iodine-based antiseptics), and alcohols are effective against human influenza viruses if used in proper concentration for a sufficient length of time. For example, wipes or gels with alcohol in them can be used to clean hands. The gels should be rubbed into hands until they are dry.

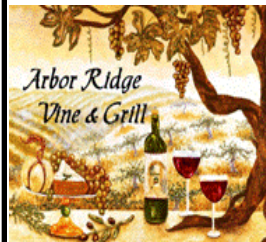

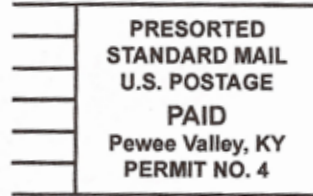
